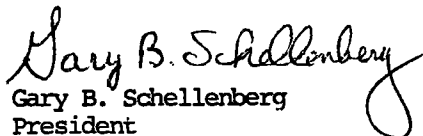

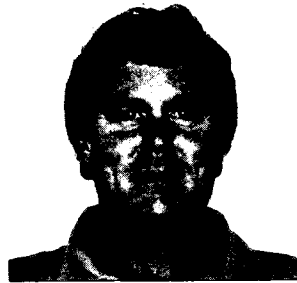

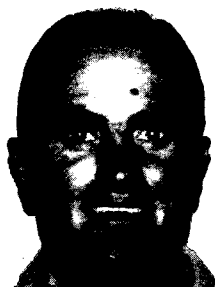

Lee entered his first Police Olympics in 1968 and became a Director of the CPAF in 1974. Since then, he has won gold medals in the Masters Mile, 4-Mile, 6-Mile, Marathon, and Mile Relay. His 1976 4-man team still holds the record for the mile relay. Lee has silver medals for Handball Doubles, 3-Mile Run, Mile Run, and Mile Relay; bronze medals for the 440 and the 3-Mile Runs.

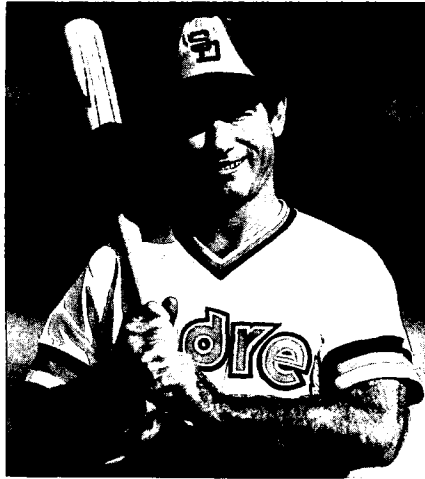

Honorary Chairman

Steve Garvey, outstanding first baseman for the San Diego Padres, has been selected by the Board of Directors of the California Police Athletic Federation to be the first Honorary Chairman of the CPAF ASSOCIATES and the World Police and Fire Games.

Steve has been a long-time supporter of law enforcement and learned of the Police Olympics through a friend, Lt. Bob Jones of the San Diego Police Department, who has competed in and coordinated Police Olympic events. Steve's enthusiasm to become a part of this program soared.

Steve Garvey's ability to excel as an athlete goes back to 1966 when he was named Athlete of the Year at Chamberlain High School in Tampa, Florida. He was drafted by the Minnesota Twins out of high school, but chose not to sign. Instead, he entered Michigan State, where he played football and became an All-American baseball player. In June of 1968, Steve became the Dodgers #1 selection in the Free Agent Draft.

Steve has six 200 hit seasons to his credit, which is exceeded by only seven players in major league history: Pete Rose (10), Ty Cobb (9), Lou Gehrig (8), Willie Keeler (8), Paul Waner (8), Charles Gehringer (7) and Roger Hornsby (7).

The Directors of the California Police Athletic Federation are extremely pleased to include Steve Garvey on "the team". His presence can only result in a greater opportunity to improve the California Police Olympics and other police athletic competitions.

- CYCLING - Add Women's Division in all categories
- GOLF - Only 144 golfers may play on one course, one day.
Add Handicap Division for 10 or more handicap.
- MARATHON - Changed to ROAD RACE (see ROAD RACE below).
- PISTOL - Add Police Distinguished Match.
- ROAD RACE - A new sport name which takes the place of MARATHON.
Distance, 30K or 18.64 miles.
- SOFTBALL - A mat will be used to call balls/strikes.
SLOPITCH Designated hitter rule will be in effect.
Women's event has been added.
- TRAP - Add Individual All Events.

GENERAL RULES

Due to recent circumstances wherein standing rules of the California Police Athletic Federation were violated, all competitors are hereby notified that any infraction of these and all rules of this organization, as set down by the California Police Athletic Federation, will be met with severe penalties, inclusive of which may be lifetime expulsion from the California Police Olympics.

1. No drinking of alcoholic beverages during competition, by competitors.
2. No use of any controlled substance during competition, by competitors.
3. No unsportsmanlike conduct wherein any competitor physically assaults another either during or after the competition is permissible.
4. No deviation from event rules as prescribed in the Rules Book of the California Police Athletic Federation, unless permitted by the C.P.A.F. prior to the start of any competition. Coordinators and the Host Agency shall be held accountable for said infractions.
5. No event, wherein the presence of a medical doctor is required, shall begin until such doctor is present and on site.
6. Any proven evidence of cheating or sandbagging in an event shall result in lifetime expulsion from the California Police Olympics.
7. Any unruly behavior which would bring discredit upon the California Police Olympics and/or law enforcement itself will not be tolerated. Non-competitor peace officers in attendance should be admonished by their competitor associates of the possible consequences of such behavior wherein any department is concerned.
8. No advertising on any uniform during competition other than your agency or association (law enforcement related).
9. There shall be no sales of any kind during the California Police Olympics, unless such sales are approved by the Board of Directors of the California Police Athletic Federation, in writing and prior to any competition.
10. No gambling of any kind will be permitted during the California Police Olympics.

VIOLATIONS AND PENALTIES

The following are actions taken by the Board of Directors of the California Police Athletic Federation, as a result of infractions occurring during the California Police Olympics in San Diego, June-July 1983.

1. Host agency failing to provide a medical doctor at a required event.

Result - Fined.

2. A competitor intentionally and forcefully delivering an unprovoked blow to the head of another competitor after having been defeated in their event.

Result - Lifetime expulsion from the California Police Olympics.

3. A competitor intentionally misrepresented himself as a peace officer in order to compete.

Result - Competitor was stripped of his gold medal and lifetime expulsion from the California Police Olympics.

4. Two competitors, one from each team, engaged in a physical altercation outside of the normal physical contact required, (fist fight).

Result - Both competitors were disqualified from the remainder of the 1983 California Police Olympics.

5. Two five-man teams were involved in drinking alcoholic beverages during competition, resulting in activity detrimental to the competition.

Results varied, from one year probation to permanent expulsion.

If any of you would like to put a Hose Cart team together, I'll send you the rules and see if I can help find you a cart to practice. Don't underestimate those firefighters. We all know they have little else to do at work (all three days a week) but wash their cars and practice for the Games. My wife works at a local hospital and discloses that more fire types are injured at work playing basketball than fighting fires. Seriously, we are planning a quality event with some of the best sport facilities and officials anywhere and with the hospitality that made San Jose one of the most memorable Police Olympics ever.

What we want is to encourage you California cops to get into your best shape ever and make a good impression on our foreign friends, not to mention embarrass the hell out of the California firefighters (and some may not be that easily embarrassed). We'll warm up in Oxnard at our own event, then top it off in San Jose with 8,000 plus athletes and international media coverage in what may be the biggest olympic type event anywhere. BE THERE.
