The maximum boxing age is 40. Boxers will be ineligible to compete on their 41st birthday. Age is determined as of the first competition day of the Games: July 28, 2023. Absolutely no Exceptions.

#### Officials

Bout Director, Technical Advisor, three judges and one referee will be present at the competition site.

#### On-site Medical

TWO(2) physicians and an Ambulance will be on site for this competition.

Basic medical supplies will be available at the venue.





Communications will be available at the venue and preparations made in case it is necessary to summon emergency services.

## **Competitors' Medical Requirements**

A medical release, based upon a medical examination performed with in ree months of WPFG's date, ri the form of the World Police and Fire Games "Report of Physical Examination", signed by a licensed physician, is required. This form may be obtained by contacting the WPFGF Office (information listed in the Guiding Bodies above) and may be mailed to WPFGF prior to the entry deadline, mailed to the Host prior to the WPFG or turned in during the registration process. A current IBA booklet "Competition Record Book for Boxers" may be substituted for the standard WPFGF form.

#### **Competitors Record Book**

It is mandatory for all the athletes to provide this information to the organising committee. Every boxer has to register with their country even if it is their first bout. They can go to their local club and register there once they have registered they will receive their record book. Contact your local club to ensure that you have the latest version.

#### Weigh-Ins

There will be one official weigh-in on the day before the first day of competition for all fighters. This weigh-in will be used to determine bracketing ad category. No further weighins are required, but may be authorized by the sports coordinator for purposes of boxer safety.

# **Sport Equipment**

#### Equipment that must be provided by the boxer

**Shoes**: All Boxers will wear Boxing/Wrestling shoes. NO exceptions.

**Mouth Protection**: A minimum of one individual customfitted mouthpiece will be provided by the competitor and presented to the technical advisor or sports coordinator prior to competition. (Red or partially red mouth guards cannot be used)





Groin protectors: Either a protective cup or Boxing groin protector shall be worn. It is mandatory for males to wear groin protectors.

Hand Wraps: Only approved hand wraps can be used during competition. These wraps may include gauze or other wrap material as appropriate. The length and amount of wrap will be appropriate to safely protect the bones in the hand of the boxer. The exact requirements will be included in the Confirmation Letters sent to all competitors.

All individual competitor equipment must be inspected and approved by WPFGF Technical Advisor and WPFGofficials at the time of weigh-in.

#### Prohibited: The following equipment shall NOT be worn:

- Eye protection or contact lenses.
  - o Note: Soft Contact Lenses, aapproved by IBA, are permitted.
- Hearing aids
- Jewelry (includes ANY body piercings)

## **Equipment Provided by the Host**

**Boxing gloves**: IBA approved 10 oz competition gloves for Mens bouts up to 67 KG and all womens bouts. All other Mens bouts will use IBA approved 12 oz competition gloves. The host will have at least 6 sets of new gloves available (12 pairs) of both 10 oz and 12 oz gloves.

Head protection: Host will have 10 sets (25mall, 3 Medium, 3 Large, 2- XL) of (20) IBA approved head protectors. The dad protection is mandatory for all boxers and will be IBA approved competition head protectors without cheek or nose guards. Colours are limited to red, blue or neutral only. Confirmation Letters are to advise all competitors of these requirements.

**Athletic Tape** will be applied to the wrist area only. The purpose of the tape is to secure the wrist of the hand wraps only. The Host will provide the tape at the direction of the WPFGF Boxing Technical Advisor.





# **Competition Format**

#### **Bracketing**

#### **Single Elimination**

- A. **The Draw**. The draw will take place after the medical examination and weigh. The draw will proceed first for the boxers to box in the first series and then for the byes.
- B. **Byes**. In competitions where there are more than four competitors a sufficient number of byes will be drawn in the first series to reduce the number of competitors in the second series to 4, 8, 16, or 32. If there are over eight (8) boxers in the same class and weight division an "A" & "B" division will be created and econd set of medals awarded. The boxing officials will divide the division taking age and experience into consideration.

If two competitors from the same department are listed together in the first round, they will be matched with another competitor, f possible. All subsequent rounds will be per bracket eliminations.

## **Scoring**

Scoring will be as per IBA international standards. The IBA approved manual 10 point scoring system will be used for all bouts.

#### **Awards**

Medals are awarded First through Third Place (with dual bronze medals for 3rd).





## **Sport Rules**

As per IBA rules, boxers who have competed in any professional boxing or any professional combat sport other than boxing will not be permitted to compete in Games at any level. (Does not include FX Toughman competition)

Male competitors must state on their application either Novice, Intermediate, Open Division 1 or Open Division 2. Female competitors must state Novice/Intermediate or Open on their Application Form. Both Male and Female competitors must include their project weight class.

**Novice Class Boxers** Will not have fought in more than 5 (five) amateur bouts.

**Intermediate Class Boxers**: Will not have fought in more than 10 (ten) amateur bouts, nor more than 10 Police Olympics, Police Summer Games, or Police and Games, International Police Olympics, Fire Olympics, or World Police and Fire Games bouts or any combination of 10 bouts thereof. This is to include contact sports (ie, kickboxing, MMA).

Open Class Division 1 Boxers/Vill not have fought in more than 2 (twenty five) amateur bouts, nor more than 25 Police Olympics, Police Summer Games, or Police and Fire Games, International Police Olympics, Fire Olympics, or World Police and Fire Games bouts or any combination of 25 bouts thereof. This is to include contact sports (ie, kickboxing, MMA).

**Open Class Division 2 Boxers**Boxers who do not qualify for either Novice, Intermediate or Open Class Division 1 (those with 25 or less bouts) will compete in this class. (ie, kickboxing, MMA).

**Note**: The Technical Adiser, in consultation with the Sports Coordinator, will move any boxer assessed as entered in the incorrect category, irrespective of the class claimed by the competitor.

- A. This is a Safety Issue & at the discretion of the Technical Adviser.
- B. Any suggestion of competitor "sand-bagging" will be the subject of disciplinary action by the responsible WPFG Federation Director.





If a competitor does not qualify for his/her projected weight class at the time of weighin, he/she has the option of fighting in his/her qualifying weight class.

Exception: In the event only one registered competitor in any weight class shows up for competition, he/she may elect to move up one weight class and compete at that level, if approved by WPFGF officials.

All entrants are required to submit a current medical release in the form of the World police and fire games "Report of Physical Examination" signed by a licensed physician.

The WPFGF or Host will provide the release form to each applicant. This form will be submitted with the competitor's entry or submitted at the time of Registration. The Coordinator is responsible for having a copy of each medical release available for the physician at the pre-fight check-up.

There will be a prefight check-up by a doctor one hour before each in the scheduled bout. There will be 2 physicians present at all times during competition.

No bouts will begin without the presence of a physician and ambulance at ringside.

There will be a stretcher, blanket and oxygen maintained at ringside.

The following items will be worn by each boxer while competing

- A. 12 oz IBA approved competition gloves.
- B. IBA approved headgear, red, blue or neutral colour is MANDATORY for ALL bouts.
- C. Mouthpiece
- D. Custom Cup & Groin Protector
- E. Trunks: Fitted Boxing trunks required and provided by the competitor
- F. Boxing or Wrestling shoes: NO EXCEPTIONS
- G. Sleeveless jersey: Boxers will require one blue and one red singlet

Dress rules will be strictly enforced. (See "Equipment" section for specifications.)





If a competitor's mouthpiece is knocked out, action will stop immediately. The mouthpiece will be cleaned and replaced by the referee or coach. If the referee determines this action to be purposeful or repetitive, the boxer may be warned or disqualified.

3 x 2 minute rounds for novice/intermediate class boxers and 3 x 3 minute rounds for both Male open class divisions. Female open class division will be 3 x 3 minute rounds.

One minute rest periods.

Only one handler in the ring - all others maximum of 3 persons may be on the apron.

Over-directing between rounds is prohibited.

Coach may throw in the towel, but is not permitted to enter the ring immediately.

Any fighter suffering a Knockout will be taken immediately to a hospital for follow-up examination. Such fighters may not compete further in the competition. Hospitalization expenses will be borne by the competitor suffering the knock-out.

No competitor will compete in more than one (1) bout in a single day.

No competitor should compete on consecutive days. Ideally, there must be one day of rest between each day of competition.

Exception: For reasons including but not limited to, numbers, draw, or timing, Boxing officials may, at their discretion, elect to:

- a. Conduct the additionally needed bouts on the offdays, beginning with the first offday. These bouts will be held at the Boxing event facility or at a properly equipped local gym. Allregulations, including officials, and medical personnel apply.
- b. Divide the affected weight class(es) so:
  - i. The numbers of boxers in each suldivision is as equal as possible and;
  - ii. The weights of the boxers in each subdivision are as close as possible. If this option is selected, times for the extra bouts and additional medals must be provided by the Host





If a fighter is considered by the referee to be outclassed by his opponent, the fight will be stopped immediately. Confirmation letters and pre-fight check-in will include an explanation of the rules on medical treatment (specifically, regarding knock-outs and financial responsibility).

Timeliness: It is the sole responsibility of the competitor to be aware of, and respond to, all required show-up times.

# **Disciplinary Action / Intervention**

The WPFGF may impossDisciplinary Action on any person or persons under the auspices of the WPFG and may take immediate action known as Intervention, for violations of WPFG Rules, for reasons of safety or security or for inappropriate or unprofessional conduct not in the best interest of the WPFG.

Allegations of Misconduct/Incidents that do not require immediate Intervention will follow the "Appeals and Protests" section of the General Rule Book or may be independently brought by the WPFGF.
