- Events with 7 players/teams will play a round robin tournament to 11 points, followed by medal matches for the top 4 players only. The gold medal match will be 1 v. 2, bronze medal match will be 3 v. 4, one games to 15, win by 2.

Events with only 2 players/teams will play the best of 3 games. These matches will be best of 3 games to 11, win by two.
