# 2025 US Police & Fire Championships Rifle-Small Bore

Welcome to the United States Police & Fire Championships. This letter serves as your Final Confirmation of your participation in Rifle-Small Bore. Rifle-Small Bore is scheduled for Monday, June 2<sup>nd</sup> at the South Bay Rod & Gun Club, located at 1020 Marron Valley Rd., Dulzura, CA 91917. The Guiding Bodies are the United States Police & Fire Championships and the National Rifle Association Small Bore Rules.

## **Conduct Expected of ALL Participants:**

Drinking of alcoholic beverages, unlawful consumption of controlled substances, and gambling is prohibited while competing. Unsportsmanlike conduct will not be condoned either before, during, or after competition. Any physical or verbal assaults on officials, competitors, spectators, coordinators or ex-officios will be met with IMMEDIATE AND SEVERE PENALTIES, including EXPULSION from these and future United States Police & Fire Championships.

A Rules Briefing will follow, with "first call" at 7:45 AM

Small Bore Rifle event will consist of three events: Individual English Prone and Individual and 4-Person Team 3-Position Match.

**IMPORTANT**: All competitors MUST enter the Individual event to shoot in the Team event.

EMPTY CHAMBER INDICATORS (Safety Flags) ARE MANDATORY AND SHALL BE IN THE ACTIONS OF ALL RIFLES, CASED OR UNCASED WHILE ON THE RANGE. THEY ARE ONLY TO BE REMOVED DURING PREP TIME AND LIVE FIRE. EYE AND EAR PROTECTION ON THE FIRING LINE IS MANDATORY.

Ammunition will not be available for purchase at the venue.

### **SMALL BORE RIFLE RULES:**

Rifles: NRA Match Rifle or any Rifle. See NRA Rule 3.1 or 3.2.

Classes: Standard Rifle and Free Rifle are combined.

Sights: See NRA Rule 3.7.

Target: NRA International A-51 will be used. See NRA Rule 4.1.

3-POSITION - COURSE OF FIRE: 50 Yard Course: NRA Course 7.5 - Sixty (60) shots in three (3) positions. Positions as follows:

Stage 1: Prone, 20 shots, 20 minutes. Stage 2: Standing, 20 shots, 40 minutes. Stage 3: Kneeling, 20 shots, 30 minutes.

English Prone - Course of Fire: 50 Yard Course: NRA Course 7.4.1 - Sixty (60) shots in prone position. Positions as follows:

Stage 1: Prone, 20 shots, 20 minutes. Stage 2: Prone, 20 shots, 20 minutes. Stage 3: Prone, 20 shots, 20 minutes.

**CLASSIFICATIONS**: USPFC Classifications will be used. Small Bore Rifle shooters with a classification from a recognized shooting sports organization (RSSO) shall shoot in their classification for their discipline. Shooters without an RSSO classification shall be classified based upon scores they shot in WSPFG matches, if available. Small Bore Rifle shooters without an established USPFC classification who cannot present such evidence will shoot their Individual event. The score they obtain on the in their Individual event will be used to determine their proper classification for the awarding of medals in the various classes in the Individual event. This classification will also be used for the Team event.

**SKILL CATEGORIES & MEDALS**: All events are Unisex Open [18+] with medals through 3rd place. (Teams may consist of all men, all women or any combination thereof.) Awards for the Individual events in both 3-Position and English Prone Match will be made in the following classifications: Master, Expert, Sharpshooter and Marksman Events. Awards for the Team events will be offered in "A" Division (Master & Expert) and "B"
